# Notes on squeezed states in $x$-space representation

#### Abstract

In these notes, we discuss squeezed states using the elementary quantum language based on one-dimensional Schrödinger equation. No operators are used. The language of quantum optics is mentioned only for a hint to solve a differential equation. Sections II and III (squeezed vacuum and pure squeezed states) can be used in a standard undergraduate course on quantum mechanics after discussion of a harmonic oscillator. Section IV discusses density matrix of mixed squeezed states in $x$-representation. These notes present explicit (therefore somewhat lengthy) step-by-step derivations. These notes are not intended for publication as a journal paper.


## I. INTRODUCTION

In quantum optics [1/4], squeezed states are usually introduced via the squeezing operator and discussed in the phase space, with the formalism based on creation and annihilation operators. Here we discuss one-dimensional squeezed states in the $x$-representation, using the formalism based only on elementary quantum mechanics [5, 6].

## II. SQUEEZED VACUUM

Let us consider a harmonic oscillator with mass $m$ and frequency $\omega$, so the potential energy is

\begin{equation*}
V(x)=\frac{1}{2} m \omega^{2} x^{2} \tag{1}
\end{equation*}
$$

The ground state of this oscillator is [5, 6]

$$
\begin{equation*}
\psi_{\mathrm{gr}}(x, t)=\frac{e^{-i \omega t / 2}}{\sqrt[4]{2 \pi \sigma_{\mathrm{gr}}^{2}}} \exp \left(-\frac{x^{2}}{4 \sigma_{\mathrm{gr}}^{2}}\right), \quad \sigma_{\mathrm{gr}}^{2}=\frac{\hbar}{2 m \omega} \tag{2}
\end{equation*}
$$

where $\sigma_{\mathrm{gr}}^{2}$ is the $x$-space variance of the ground state probability distribution $\left|\psi_{\mathrm{gr}}(t)\right|^{2}$.

Suppose we have prepared an initial state $\psi(x, 0)=$ $\exp \left(-x^{2} / 4 D\right) /$ Norm. What is the further evolution $\psi(x, t)$ of this state? If $D=\sigma_{\mathrm{gr}}^{2}$, then we have prepared the ground state and therefore it will not evolve (except for the trivial time-factor $e^{-i \omega t / 2}$ due to the ground state energy $\hbar \omega / 2$ ). If $D \neq \sigma_{\mathrm{gr}}^{2}$, then this state is called a squeezed vacuum (especially if $D<\sigma_{\mathrm{gr}}^{2}$ ). Our goal in this section is to find the explicit time-dependence $\psi(x, t)$ for the squeezed vacuum in $x$-space.

In quantum optics language, the time-dependence of the squeezed vacuum corresponds to the rotation of quadrature axes with frequency $\omega$. From the picture of an ellipse representing the squeezed vacuum in optics, we know that $\psi(x, t)$ should be periodic with frequency $2 \omega$ (except for an accumulating phase). And we also know that a Gaussian state should remain Gaussian with rotation of axes. Also, since $\psi(x, 0)$ is symmetric (even), this symmetry should remain in time.

Therefore, the squeezed vacuum should be

$$
\begin{equation*}
\psi(x, t)=\frac{1}{\sqrt[4]{2 \pi \sigma_{\mathrm{gr}}^{2} A(t)}} \exp \left(-\frac{x^{2}[1+i B(t)]}{4 \sigma_{\mathrm{gr}}^{2} A(t)}\right) e^{-i \varphi(t)} \tag{3}
\end{equation*}
$$

where $A(t), B(t)$, and $\varphi(t)$ are real dimensionless functions of time, with $A(t)$ and $B(t)$ being $2 \omega$-periodic (note that this state is already normalized). In particular, for the ground state $A(t)=1, B(t)=0$, and $\varphi(t)=\omega t / 2$. Let us find $A(t), B(t)$, and $\varphi(t)$ for the squeezed vacuum.

To use the Schrödinger equation [5, 6],

$$
\begin{equation*}
i \hbar \frac{\partial \psi}{\partial t}=-\frac{\hbar^{2}}{2 m} \frac{\partial^{2} \psi}{d x^{2}}+\frac{1}{2} m \omega^{2} x^{2} \psi \tag{4}
\end{equation*}
$$

we need to calculate $\partial \psi / \partial t$ and $\partial^{2} \psi / d x^{2}$. This can be easily done for the wavefunction (3),

$$
\begin{align*}
& \frac{\partial \psi}{\partial t}=\left[-\frac{\dot{A}}{4 A}+\frac{x^{2}(1+i B) \dot{A}}{4 \sigma_{\mathrm{gr}}^{2} A^{2}}-\frac{i x^{2} \dot{B}}{4 \sigma_{\mathrm{gr}}^{2} A}-i \dot{\varphi}\right] \psi  \tag{5}\\
& \frac{\partial^{2} \psi}{\partial x^{2}}=\left[\left(-\frac{x(1+i B)}{2 \sigma_{\mathrm{gr}}^{2} A}\right)^{2}-\frac{1+i B}{2 \sigma_{\mathrm{gr}}^{2} A}\right] \psi . \tag{6}
\end{align*}
$$

Substituting these derivatives into the Schrödinger equation, we obtain

$$
\begin{align*}
i \hbar & {\left[-\frac{\dot{A}}{4 A}+\frac{x^{2}(1+i B) \dot{A}}{4 \sigma_{\mathrm{gr}}^{2} A^{2}}-\frac{i x^{2} \dot{B}}{4 \sigma_{\mathrm{gr}}^{2} A}-i \dot{\varphi}\right]=} \\
& =-\frac{\hbar^{2}}{2 m}\left[\frac{x^{2}(1+i B)^{2}}{4 \sigma_{\mathrm{gr}}^{4} A^{2}}-\frac{1+i B}{2 \sigma_{\mathrm{gr}}^{2} A}\right]+\frac{1}{2} m \omega^{2} x^{2} \tag{7}
\end{align*}
$$

which is the same as

$$
\begin{align*}
& -\frac{\dot{A}}{A}+\frac{x^{2}(1+i B) \dot{A}}{\sigma_{\mathrm{gr}}^{2} A^{2}}-\frac{i x^{2} \dot{B}}{\sigma_{\mathrm{gr}}^{2} A}-4 i \dot{\varphi}= \\
& \quad=\frac{i \hbar}{2 m}\left[\frac{x^{2}(1+i B)^{2}}{\sigma_{\mathrm{gr}}^{4} A^{2}}-2 \frac{1+i B}{\sigma_{\mathrm{gr}}^{2} A}\right]-\frac{2 i}{\hbar} m \omega^{2} x^{2} . \tag{8}
\end{align*}
$$

Since this relation is valid for any $x$, it gives us two equations: for $x^{2}$-tems and for $x^{0}$-terms. Let us start with the equation for $x^{2}$-component (multiplied by $\sigma_{\mathrm{gr}}^{2}$ ),

$$
\begin{equation*}
\frac{(1+i B) \dot{A}}{A^{2}}-\frac{i \dot{B}}{A}=\frac{i \hbar(1+i B)^{2}}{2 m \sigma_{\mathrm{gr}}^{2} A^{2}}-\frac{2 i}{\hbar} m \omega^{2} \sigma_{\mathrm{gr}}^{2} \tag{9}
\end{equation*}
$$

Using $\sigma_{\mathrm{gr}}^{2}=\hbar /(2 m \omega)$ and multiplying all terms by $A^{2}$, we can rewrite Eq. (9) as

$$
\begin{equation*}
(1+i B) \dot{A}-i A \dot{B}=i \omega(1+i B)^{2}-i \omega A^{2} \tag{10}
\end{equation*}
$$

Since $A$ and $B$ are real, this equation gives us two equations: for the real and imaginary components,

$$
\begin{align*}
& \dot{A}=-2 \omega B  \tag{11}\\
& B \dot{A}-A \dot{B}=\omega\left(1-B^{2}-A^{2}\right) \tag{12}
\end{align*}
$$

These two equations are sufficient to find $A(t)$ and $B(t)$. We will discuss the solution a little later; before that, let us consider the $x^{0}$-component of Eq. (8), which is

$$
\begin{equation*}
-\frac{\dot{A}}{A}-4 i \dot{\varphi}=-\frac{i \hbar}{m} \frac{1+i B}{\sigma_{\mathrm{gr}}^{2} A}=\frac{2 \omega}{A}(-i+B) \tag{13}
\end{equation*}
$$

The real part of this equation gives $\dot{A}=-2 \omega B$, which is the same as Eq. (11). The imaginary part gives

$$
\begin{equation*}
\dot{\varphi}=\frac{\omega}{2 A} \tag{14}
\end{equation*}
$$

from which we can find $\varphi(t)$ if we know $A(t)$.
Thus, we only have to solve Eqs. (11) and (12). Since we know that both $A(t)$ and $B(t)$ should be periodic with frequency $2 \omega$, it is quite simple to guess the solution:

$$
\begin{align*}
& A(t)=A_{0}+\Delta A \cos \left(2 \omega t+\phi_{\mathrm{sq}}\right)  \tag{15}\\
& B(t)=\Delta A \sin \left(2 \omega t+\phi_{\mathrm{sq}}\right) \tag{16}
\end{align*}
$$

where $\phi_{\mathrm{sq}}$ is the initial phase for oscillations of squeezing and $A_{0}>\Delta A \geq 0$. It is easy to see that Eq. (11) is satisfied for any $A_{0}, \Delta A$, and $\phi_{\text {sq }}$, while to satisfy Eq. (12) we need the condition

$$
\begin{equation*}
\left(A_{0}+\Delta A\right)\left(A_{0}-\Delta A\right)=1 \tag{17}
\end{equation*}
$$

which is a familiar condition for the product of minimum and maximum quadrature variances of a squeezed state. Note that for the initial state discussed at the beginning, we need $\phi_{\text {sq }}=n \pi$ with an integer $n$. Also note that the squeezed vacuum (3) is a minimum-uncertainty state, $\sigma_{x} \sigma_{p}=\hbar / 2$, only when $2 \omega t+\phi_{\mathrm{sq}}=n \pi$ with integer $n$, i.e., four times per oscillator period.

Thus, we have found the evolution of the squeezed vacuum (3) up to the overall phase $\varphi(t)$, which is not quite important and can be found via Eq. (14). It is interesting that there is an explicit solution,

$$
\begin{align*}
\varphi(t) & =\frac{\omega}{2} \int^{t} \frac{d t^{\prime}}{A_{0}+\Delta A \cos \left(2 \omega t^{\prime}+\phi_{\mathrm{sq}}\right)}  \tag{18}\\
& =\frac{1}{2} \operatorname{atan}\left[\left(A_{0}-\Delta A\right) \tan \left(\omega t+\frac{\phi_{\mathrm{sq}}}{2}\right)\right]+\mathrm{const} \tag{19}
\end{align*}
$$

where each discontinuity of the tangent should be compensated by an increase of the constant by $\pi / 2$. Note that in deriving Eq. (19) we have used Eq. (17). It is easy to see that for each $\Delta t=\pi / \omega$ (half-period), the phase increases by $\Delta \varphi=\pi / 2$, so that $\Delta \varphi / \Delta t=\omega / 2$, which is the same value as for the ground state.

## III. PURE SQUEEZED STATES

Now let us generalize the $x$-space evolution of the squeezed vacuum to the $x$-space evolution of an arbitrary (pure) squeezed state. Since we know that for a squeezed state the evolution of the center is decoupled from squeezing, it is natural to guess the following wavefunction for a squeezed state:

$$
\begin{align*}
\psi(x, t)= & \frac{1}{\sqrt[4]{2 \pi \sigma_{\mathrm{gr}}^{2} A}} \exp \left[-\frac{\left(x-x_{\mathrm{c}}\right)^{2}(1+i B)}{4 \sigma_{\mathrm{gr}}^{2} A}\right] \\
& \times \exp \left(i p_{\mathrm{c}} x / \hbar\right) e^{-i \varphi} \tag{20}
\end{align*}
$$

where $A(t)$ and $B(t)$ are the same functions of time as for the squeezed vacuum [given by Eqs. (15)-(17)], while the overall phase $\varphi(t)$ is now different, and the state center evolves classically,

$$
\begin{align*}
& x_{\mathrm{c}}=X_{\mathrm{amp}} \cos \left(\omega t+\phi_{\mathrm{c}}\right)  \tag{21}\\
& p_{\mathrm{c}}=m \dot{x}_{\mathrm{c}}=-m \omega X_{\mathrm{amp}} \sin \left(\omega t+\phi_{\mathrm{c}}\right) \tag{22}
\end{align*}
$$

where $X_{\mathrm{amp}}$ is the amplitude of classical oscillations of the center and the initial phase $\phi_{\mathrm{c}}$ is not related to the initial phase $\phi_{\text {sq }}$ of squeezing oscillations. Let us show that the time-dependence of an arbitrary squeezed state given by Eqs. (20)-(22) and (15)-(17) satisfy the Schrödinger equation.

The derivatives of $\psi(x, t)$ given by Eq. (20) are

$$
\begin{align*}
\frac{\partial \psi}{\partial t}= & {\left[-\frac{\dot{A}}{4 A}+\frac{\left(x-x_{\mathrm{c}}\right)^{2}(1+i B) \dot{A}}{4 \sigma_{\mathrm{gr}}^{2} A^{2}}-\frac{i\left(x-x_{\mathrm{c}}\right)^{2} \dot{B}}{4 \sigma_{\mathrm{gr}}^{2} A}\right.} \\
& \left.+\frac{\left(x-x_{\mathrm{c}}\right) \dot{x}_{\mathrm{c}}(1+i B)}{2 \sigma_{\mathrm{gr}}^{2} A}+\frac{i \dot{p}_{\mathrm{c}} x}{\hbar}-i \dot{\varphi}\right] \psi  \tag{23}\\
\frac{\partial^{2} \psi}{\partial x^{2}}= & {\left[\left[-\frac{\left(x-x_{\mathrm{c}}\right)(1+i B)}{2 \sigma_{\mathrm{gr}}^{2} A}+\frac{i p_{\mathrm{c}}}{\hbar}\right]^{2}-\frac{1+i B}{2 \sigma_{\mathrm{gr}}^{2} A}\right] \psi, } \tag{24}
\end{align*}
$$

so the Schrödinger equation is [instead of Eq. (8)]

$$
\begin{align*}
-\frac{\dot{A}}{A}+ & \frac{\left(x-x_{\mathrm{c}}\right)^{2}(1+i B) \dot{A}}{\sigma_{\mathrm{gr}}^{2} A^{2}}-\frac{i\left(x-x_{\mathrm{c}}\right)^{2} \dot{B}}{\sigma_{\mathrm{gr}}^{2} A}-4 i \dot{\varphi} \\
& +\frac{2\left(x-x_{\mathrm{c}}\right) \dot{x}_{\mathrm{c}}(1+i B)}{\sigma_{\mathrm{gr}}^{2} A}+4 i \frac{\dot{p}_{\mathrm{c}} x}{\hbar}= \\
= & \frac{i \hbar}{2 m}\left[\frac{\left(x-x_{\mathrm{c}}\right)^{2}(1+i B)^{2}}{\sigma_{\mathrm{gr}}^{4} A^{2}}-2 \frac{1+i B}{\sigma_{\mathrm{gr}}^{2} A}-4 \frac{p_{\mathrm{c}}^{2}}{\hbar^{2}}\right. \\
& \left.-4 i \frac{p_{\mathrm{c}}}{\hbar} \frac{\left(x-x_{\mathrm{c}}\right)(1+i B)}{\sigma_{\mathrm{gr}}^{2} A}\right]-\frac{2 i}{\hbar} m \omega^{2} x^{2} . \tag{25}
\end{align*}
$$

This equation now gives three equations: for $x^{2}, x^{1}$, and $x^{0}$ components. It is easy to check that the $x^{2}$ component still gives Eq. (9). Therefore, Eqs. (11)-(12) for $A(t)$ and $B(t)$ and correspondingly their solutions, Eqs. (15) -17), are still valid for an arbitrary squeezed state. The $x^{1}$-component of Eq. (25) multiplied by $\sigma_{\mathrm{gr}}^{2}$
gives

$$
\begin{gather*}
\frac{-2 x_{\mathrm{c}}(1+i B) \dot{A}}{A^{2}}+\frac{2 i x_{\mathrm{c}} \dot{B}}{A}+\frac{2 \dot{x}_{\mathrm{c}}(1+i B)}{A}+4 i \frac{\dot{p}_{\mathrm{c}}}{\hbar} \sigma_{\mathrm{gr}}^{2}= \\
\quad=\frac{i \hbar}{2 m} \frac{-2 x_{\mathrm{c}}(1+i B)^{2}}{\sigma_{\mathrm{gr}}^{2} A^{2}}+\frac{2 p_{\mathrm{c}}}{m} \frac{1+i B}{A} . \tag{26}
\end{gather*}
$$

Note that several terms here are the same as the terms in Eq. (9) multiplied by $-2 x_{\mathrm{c}}$. Subtracting Eq. (9) multiplied by $-2 x_{\mathrm{c}}$ from Eq. (26) and using $\sigma_{\mathrm{gr}}^{2}=\hbar / 2 m \omega$, we obtain

$$
\begin{equation*}
\frac{2 \dot{x}_{\mathrm{c}}(1+i B)}{A}+2 i \frac{\dot{p}_{\mathrm{c}}}{m \omega}=\frac{2 p_{\mathrm{c}}}{m} \frac{1+i B}{A}-2 i x_{\mathrm{c}} \omega \tag{27}
\end{equation*}
$$

which is obviously satisfied for $x_{\mathrm{c}}$ and $p_{\mathrm{c}}$ given by Eqs. (21) and (22). Thus, the $x^{1}$-component of Eq. (25) is satisfied. Finally, the $x^{0}$-component gives

$$
\begin{aligned}
& -\frac{\dot{A}}{A}+\frac{x_{\mathrm{c}}^{2}(1+i B) \dot{A}}{\sigma_{\mathrm{gr}}^{2} A^{2}}-\frac{i x_{\mathrm{c}}^{2} \dot{B}}{\sigma_{\mathrm{gr}}^{2} A}-4 i \dot{\varphi}-\frac{2 x_{\mathrm{c}} \dot{x}_{\mathrm{c}}(1+i B)}{\sigma_{\mathrm{gr}}^{2} A}= \\
& \frac{i \hbar}{2 m}\left[\frac{x_{\mathrm{c}}^{2}(1+i B)^{2}}{\sigma_{\mathrm{gr}}^{4} A^{2}}-2 \frac{1+i B}{\sigma_{\mathrm{gr}}^{2} A}-4 \frac{p_{\mathrm{c}}^{2}}{\hbar^{2}}+4 i \frac{p_{\mathrm{c}}}{\hbar} \frac{x_{\mathrm{c}}(1+i B)}{\sigma_{\mathrm{gr}}^{2} A}\right]
\end{aligned}
$$

The real part of this equation is

$$
\begin{equation*}
-\frac{\dot{A}}{A}+\frac{x_{\mathrm{c}}^{2} \dot{A}}{\sigma_{\mathrm{gr}}^{2} A^{2}}-\frac{2 x_{\mathrm{c}} \dot{x}_{\mathrm{c}}}{\sigma_{\mathrm{gr}}^{2} A}=\frac{\hbar B}{m \sigma_{\mathrm{gr}}^{2} A}-\frac{\hbar x_{\mathrm{c}}^{2} B}{m \sigma_{\mathrm{gr}}^{4} A^{2}}-2 \frac{p_{\mathrm{c}} x_{\mathrm{c}}}{m \sigma_{\mathrm{gr}}^{2} A} \tag{29}
\end{equation*}
$$

The first terms on both sides are equal to each other because $\dot{A}=-2 \omega B$ [see Eq. (11)]. The second terms are equal because of the same reason. The third terms are equal because $\dot{x}_{\mathrm{c}}=p_{\mathrm{c}} / m$. So, Eq. (29) is satisfied. Finally, the imaginary part of Eq. (28) gives (after some algebra)

$$
\begin{align*}
\dot{\varphi} & =\frac{\omega}{2 A}+\frac{x_{\mathrm{c}}^{2} B \dot{A}}{4 \sigma_{\mathrm{gr}}^{2} A^{2}}-\frac{x_{\mathrm{c}}^{2} \dot{B}}{4 \sigma_{\mathrm{gr}}^{2} A}-\frac{\omega x_{\mathrm{c}}^{2}\left(1-B^{2}\right)}{4 \sigma_{\mathrm{gr}}^{2} A^{2}}+\frac{p_{\mathrm{c}}^{2}}{2 \hbar m} \\
& =\frac{\omega}{2 A}+\frac{m \omega^{2}\left(X_{\mathrm{amp}}^{2}-x_{\mathrm{c}}^{2}\right)}{2 \hbar} \tag{30}
\end{align*}
$$

It is simple to solve this equation by adding the explicit solution (19) for $x_{\mathrm{c}}=X_{\mathrm{amp}}=0$ and the integral of the last term in Eq. (30).

Thus, we have shown that the general (pure) squeezed state in $x$-space has the form given by Eqs. (20)-(22), (15) -(17), and (30).

## IV. MIXED SQUEEZED (GAUSSIAN) STATES

Using the wavefunction (20), let us construct the density matrix

$$
\begin{align*}
& \rho\left(x, x^{\prime}\right)=\psi(x) \psi^{*}\left(x^{\prime}\right)=\frac{1}{\sqrt{2 \pi \sigma_{\mathrm{gr}}^{2} A}} \exp \left[-\frac{\left(\frac{x+x^{\prime}}{2}-x_{\mathrm{c}}\right)^{2}}{2 \sigma_{\mathrm{gr}}^{2} A}\right] \\
& \quad \times \exp \left[-\frac{\left(\frac{x-x^{\prime}}{2}\right)^{2}}{2 \sigma_{\mathrm{gr}}^{2} A}\right] \exp \left[-i B \frac{\left(\frac{x+x^{\prime}}{2}-x_{\mathrm{c}}\right)\left(x-x^{\prime}\right)}{2 \sigma_{\mathrm{gr}}^{2} A}\right] \\
& \quad \times \exp \left[i \frac{p_{\mathrm{c}}\left(x-x^{\prime}\right)}{\hbar}\right] . \tag{31}
\end{align*}
$$

Now let us probabilistically mix the states with $x_{\mathrm{c}}$ and $p_{\mathrm{c}}$ having the Gaussian probability distribution

$$
\begin{align*}
p\left(x_{\mathrm{c}}, p_{\mathrm{c}}\right) & =\frac{1}{\sqrt{2 \pi \sigma_{\mathrm{a}}^{2}}} \exp \left[-\frac{\left(x_{\mathrm{c}}-\bar{x}_{\mathrm{c}}\right)^{2}}{2 \sigma_{\mathrm{a}}^{2}}\right] \\
& \times \frac{1}{\sqrt{2 \pi\left(m \omega \sigma_{\mathrm{a}}\right)^{2}}} \exp \left[-\frac{\left(p_{\mathrm{c}}-\bar{p}_{\mathrm{c}}\right)^{2}}{2\left(m \omega \sigma_{\mathrm{a}}\right)^{2}}\right] \tag{32}
\end{align*}
$$

so that the additional $x_{\mathrm{c}}$-spread has variance $\sigma_{\mathrm{a}}^{2}$ and the spread of $p_{c} / m \omega$ has the same variance $\sigma_{a}^{2}$, while the averaged centers $\bar{x}_{\mathrm{c}}$ and $\bar{p}_{\mathrm{c}}$ evolve according to Eqs. (21) (28) and (22), i.e.,

$$
\begin{equation*}
\dot{\bar{x}}_{\mathrm{c}}=\bar{p}_{\mathrm{c}} / m, \quad \dot{\bar{p}}_{\mathrm{c}}=-m \omega^{2} \bar{x}_{\mathrm{c}} \tag{33}
\end{equation*}
$$

It is easy to see that the evolution (33) of $\bar{x}_{\mathrm{c}}$ and $\bar{p}_{\mathrm{c}}$ does not change the probability distribution (32) for $x_{\mathrm{c}}$ and $p_{\mathrm{c}}$, which evolve according to Eqs. (21)-(22). The easiest way to see this fact is to consider an evolution on the plane of $x_{\mathrm{c}}$ and $p_{\mathrm{c}} / m \omega$, so that Eqs. (21)-(22) as well as (33) describe a rotation with frequency $\omega$ along a circle, while the Gaussian distribution (32) is isotropic. Therefore, if we average the density matrix (31) over $x_{\mathrm{c}}$ and $p_{\mathrm{c}}$ with the distribution (32), the result automatically satisfies the Schrödinger equation.

For averaging the density matrix (31) over $x_{\mathrm{c}}$, the following formula is useful:

$$
\begin{align*}
& \int_{-\infty}^{\infty} \frac{\exp \left[-\frac{(x+y)^{2}+a(x+y)}{2 \sigma_{1}^{2}}\right]}{\sqrt{2 \pi \sigma_{1}^{2}}} \frac{\exp \left(-\frac{y^{2}}{2 \sigma_{2}^{2}}\right)}{\sqrt{2 \pi \sigma_{2}^{2}}} d y= \\
& \quad=\frac{\exp \left[-\frac{x^{2}+a x}{2\left(\sigma_{1}^{2}+\sigma_{2}^{2}\right)}\right]}{\sqrt{2 \pi\left(\sigma_{1}^{2}+\sigma_{2}^{2}\right)}} \exp \left[\frac{a^{2} \sigma_{2}^{2}}{8 \sigma_{1}^{2}\left(\sigma_{1}^{2}+\sigma_{2}^{2}\right)}\right] \tag{34}
\end{align*}
$$

where $a$ can be complex. Similarly, for averaging over $p_{\mathrm{c}}$ we can use

$$
\begin{equation*}
\int_{-\infty}^{\infty} e^{a(x+y)} \frac{\exp \left(-y^{2} / 2 \sigma^{2}\right)}{\sqrt{2 \pi \sigma^{2}}} d y=e^{a x} \exp \left(a^{2} \sigma^{2} / 2\right) \tag{35}
\end{equation*}
$$

Therefore, averaging of the density matrix (31) over the
distribution (32) gives

$$
\begin{aligned}
& \rho\left(x, x^{\prime}\right)=\frac{1}{\sqrt{2 \pi \sigma_{\Sigma}^{2}}} \exp \left[-\frac{\left(\frac{x+x^{\prime}}{2}-\bar{x}_{\mathrm{c}}\right)^{2}}{2 \sigma_{\Sigma}^{2}}\right] \\
& \quad \times \exp \left[-i B \frac{\left(\frac{x+x^{\prime}}{2}-\bar{x}_{\mathrm{c}}\right)\left(x-x^{\prime}\right)}{2 \sigma_{\Sigma}^{2}}\right] \exp \left[i \frac{\bar{p}_{\mathrm{c}}\left(x-x^{\prime}\right)}{\hbar}\right] \\
& \times \exp \left[-\frac{\left(\frac{x-x^{\prime}}{2}\right)^{2}}{2 \sigma_{\mathrm{gr}}^{2} A}-\frac{B^{2} \sigma_{\mathrm{a}}^{2}\left(x-x^{\prime}\right)^{2}}{8 \sigma_{\mathrm{gr}}^{2} A \sigma_{\Sigma}^{2}}-\frac{\sigma_{\mathrm{a}}^{2}\left(x-x^{\prime}\right)^{2}}{8 \sigma_{\mathrm{gr}}^{4}}\right],(36)
\end{aligned}
$$

where $\sigma_{\Sigma}^{2}=\sigma_{\mathrm{gr}}^{2} A+\sigma_{\mathrm{a}}^{2}$. Using Eqs. (15)-(17), the last exponential factor can be expressed as

$$
\begin{equation*}
\exp \left[-\frac{\left(\frac{x-x^{\prime}}{2}\right)^{2}}{2 \sigma_{\Sigma}^{2}} \frac{\sigma_{\mathrm{gr}}^{4}+\sigma_{\mathrm{a}}^{4}+2 A_{0} \sigma_{\mathrm{gr}}^{2} \sigma_{\mathrm{a}}^{2}}{\sigma_{\mathrm{gr}}^{4}}\right] \tag{37}
\end{equation*}
$$

We see that if we introduce $\tilde{A} \equiv A+\sigma_{\mathrm{a}}^{2} / \sigma_{\mathrm{gr}}^{2}$ and $\tilde{A}_{0} \equiv A_{0}+\sigma_{\mathrm{a}}^{2} / \sigma_{\mathrm{gr}}^{2}$, then $\sigma_{\Sigma}^{2}=\sigma_{\mathrm{gr}}^{2} \tilde{A}$ and the second fraction in Eq. (37) can be rewritten as $1+\left(\sigma_{\mathrm{a}} / \sigma_{\mathrm{gr}}\right)^{4}+$ $2 A_{0}\left(\sigma_{\mathrm{a}} / \sigma_{\mathrm{gr}}\right)^{2}=P=\left(\tilde{A}_{0}+\Delta A\right)\left(\tilde{A}_{0}-\Delta A\right)$.

Therefore, removing tilde signs and overbars $(\tilde{A} \rightarrow A$, $\tilde{A}_{0} \rightarrow A_{0}, \bar{x}_{\mathrm{c}} \rightarrow x_{\mathrm{c}}, \bar{p}_{\mathrm{c}} \rightarrow p_{\mathrm{c}}$ ), we can rewrite the averaged density matrix (36) as

$$
\begin{align*}
& \rho\left(x, x^{\prime}\right)=\frac{1}{\sqrt{2 \pi \sigma_{\mathrm{gr}}^{2} A}} \exp \left[-\frac{\left(\frac{x+x^{\prime}}{2}-x_{\mathrm{c}}\right)^{2}}{2 \sigma_{\mathrm{gr}}^{2} A}\right] \\
& \quad \times \exp \left[-P \frac{\left(\frac{x-x^{\prime}}{2}\right)^{2}}{2 \sigma_{\mathrm{gr}}^{2} A}\right] \exp \left[-i B \frac{\left(\frac{x+x^{\prime}}{2}-x_{\mathrm{c}}\right)\left(x-x^{\prime}\right)}{2 \sigma_{\mathrm{gr}}^{2} A}\right] \\
& \quad \times \exp \left[i \frac{p_{\mathrm{c}}\left(x-x^{\prime}\right)}{\hbar}\right] \tag{38}
\end{align*}
$$

which differs from Eq. (31) for the pure state by only the factor $P$ in the second exponent. This is the general form of a Gaussian state of an oscillator. In Eq. (38), the time-dependence of the center $\left(x_{\mathrm{c}}, p_{\mathrm{c}}\right)$ is classical and is given by Eqs. (21) and (22); the center oscillates with frequency $\omega$. The parameters $A(t)$ and $B(t)$ are given by Eqs. (15) and (16), they oscillate with frequency $2 \omega$. The parameter $P$ is the product of maximum and minimum dimensionless variances,

$$
\begin{equation*}
P=A_{\max } A_{\min }=\left(A_{0}+\Delta A\right)\left(A_{0}-\Delta A\right) \geq 1 \tag{39}
\end{equation*}
$$

so that $P=1$ corresponds to a pure state, while $P>1$ corresponds to a mixed Gaussian state.

## V. SUMMARY

In the $x$-space representation, the squeezed vacuum wavefunction is given by Eq. (3) with dimensionless variance $A(t)$ and phase parameter $B(t)$ given by Eqs. (15) (17), and the overall phase $\varphi(t)$ given by Eq. (19). For an oscillator with frequency $\omega$, the shape of the wavefunction oscillates with frequency $2 \omega$.

The wavefunction of a pure squeezed state is given by Eq. (20) with the same parameters $A(t)$ and $B(t)$ as for the squeezed vacuum, while the center position $x_{\mathrm{c}}(t)$ and momentum $p_{\mathrm{c}}(t)$ are given by Eqs. (21) and (22). The center oscillates with frequency $\omega$, while the variance oscillates with frequency $2 \omega$.

The density matrix of a mixed (Gaussian) squeezed state is given by Eq. (38) with the same equations for $A(t), B(t), x_{\mathrm{c}}(t)$, and $p_{\mathrm{c}}(t)$, but with an additional parameter $P$ given by Eq. (39), which replaces Eq. (17).
